# The SCARD Surgical Audit CPD Program

The SCARD surgical audit is a tool which tracks the diagnostic and therapeutic process in real-time to optimise patient safety as well as providing feedback-on-demand with respect to the practitioner.

SCARD is designed to facilitate self-auditing by skin cancer practitioners working in primary care.

By undertaking self-auditing and performing analysis with the SCARD Data Pool, practitioners demonstrate their Continuing Professional Development (CPD) and ongoing education.

## **Enrolment**

Practitioners can elect to participate in the SCARD Surgical Audit CPD Program via the "CPD Enrolment" item in the "Preferences" menu from their SCARD Dashboard.

Please note that registrations must be validated prior to activation by the supervising practitioner.

# **Surgical Audit Outcomes**

By participating in the SCARD audit, practitioners can determine the following indicators:

- Number Needed to Treat (NNT): Number of Lesions tested to find one melanoma.
- Percentage of biopsies/excisions for non-melanoma skin cancer which are malignant.
- Diagnostic accuracy for the various skin malignancies.
- Ratio of New BCCs to New Melanomas.
- Proportion of definitive management procedures which are complex (flaps and grafts).
- A breakdown of lesions by type.
- A breakdown of melanomas by site.
- A breakdown of procedures performed to diagnose malignant and benign lesions.

The SCARD Audit also provides details on the practitioner's surgical performance for the following:

- **Accuracy**: Practitioners can review their percentage breakdown for diagnostic accuracy based on their provisional diagnosis at time of excision / initial treatment.
- **Adequacy**: Practitioners can view their percentage breakdown for definitively managed malignant cases where surgical margins were adequate with a breakdown by lesion type.

# **Collection periods**

The SCARD surgical audit is performed over an initial 2-month period followed by a secondary 2-month period for comparison.

A minimum of 40 consecutive specimens per collection period should be captured to provide a broad cross-section of lesion types and treatments. For collection, a specimen is either a new or a previously treated lesion (known as "not new") entered into SCARD with the provisional diagnosis and results recorded.

# Reporting

By collecting data for the two separate periods, practitioners are able to compare the SCARD reports of each period to identify any noticeable differences in the results.

# Long term observations

With continuous use of SCARD as a self-auditing tool, practitioners will be able to gauge their performance and improvement over time. The typical long-term changes observed are:

- Improved recognition of Melanoma & Non-Melanoma Skin Cancer (NMSC) will improve practitioner's Positive Predictive Value; correctly identifying the lesion with the provisional diagnosis.
- Percentage of melanomas that are in-situ (disregarding initial consultations with each patient) is a surrogate for improved diagnostic accuracy (sensitivity).
- NNT is a surrogate for improved specificity (not excising so many benign lesions).
- Increased Adequacy of treatment for Melanoma & NMSC with greater proportion of adequate margins.

## **Submission to SCARD**

Once the collection periods are completed and the comparison reports have been generated, the deidentified results are reported to the SCARD pool. The pool results are assessed & upon meeting the requirements, practitioners are recorded as completing the SCARD Surgical Audit CPD Program.

# **College recognition**

The SCARD Surgical Audit is recognised with several medical colleges as a self-auditing and quality improvement program for continuing professional development. By completing the requirements of the SCARD Surgical Audit CPD program, practitioners are eligible for recognition with the following:

- RACGP The Royal Australian College of General Practitioners
- ACRRM Australian College of Rural and Remote Medicine
- RNZCGP The Royal New Zealand College of General Practitioners

Practitioners can select which colleges they wish to receive recognition for based on their requirements as well as college membership.

### RACGP - The Royal Australian College of General Practitioners

SCARD is approved activity for the Royal Australian College of General Practitioners Quality Improvement & Continuing Professional Development (QI&CPD) Program. Use of SCARD as a clinical audit is also recognised as a QI activity by the RACGP.

Participants of the SCARD Surgical Audit who complete the CPD program are eligible for 40 Category 1 points for the Triennium as well as recording SCARD as a required QI activity.

**Reporting**: Practitioners who complete the requirements will be recorded on the Program

Attendance List at the end of the calendar year the CPD program is first completed.

Outcome: 40 Category 1 QI&CPD Points plus a QI Activity for the RACGP per triennium.

**Fee**: \$330 for the 2017-2019 triennium\*.



#### ACRRM - Australian College of Rural and Remote Medicine

SCARD Systems is a registered Education Provider with the Australian College of Rural and Remote Medicine and SCARD is a registered Clinical Audit for the 2017-2017 triennium.

Participants of the SCARD Surgical Audit who complete the CPD program are eligible for 30 Professional Development Program (PDP) points & 30 Maintenance of Professional Standards (MOPS) points.

**Reporting**: Practitioners who complete the requirements will be recorded on the

ACRRM Professional Development Program Attendance List for submission to ACRRM at the end of the calendar year the CPD program is first completed.

**Outcome**: 30 PDP Points plus 30 MOPS points for ACRRM per triennium.

**Fee**: No fees applicable for the 2017-2019 triennium.

### RNZCGP - The Royal New Zealand College of General Practitioners

SCARD is Approved Practice/Primary Health Organisation audit for the Royal New Zealand College of General Practitioners Maintenance of Professional Standards (MOPS) & Continuing Professional Development (CPD) Program.

Participants of the SCARD Surgical Audit who complete the CPD program are eligible to claim for two audit cycles with 10 CPD/MOPS credits for each audit cycle; a total 20 CPD/MOPS credits for the triennium.

Reporting: Doctors must complete an RNZCGP summary sheet outlining the action plan that

they intend to implement based on the audit results.

Participants record completion on the CPD/MOPS Online credit summary, under the

Audit of Medical Practice section.

From the drop down menu GP's select "Approved Practice/PHO audit " and record the audit name - "SCARD Surgical audit", the audit date for the cycle and 10 credits.

Outcome: Total 20 CPD/MOPS credits (10 CPD/MOPS credits per cycle) per triennium.

Fee: No fees applicable for the 2017-2019 triennium.
